I- INTRODUCTION

In order to provide certain services, we need to process your personal data. For these purposes, they will be included in the relevant processing activities undertaken by TELEFÓNICA FACTORING ESPAÑA,S.A. and shall be processed only for the specific purpose of each processing action, mainly in accordance with the regulations set forth in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) and Organic Act 3/2018, of December 5, on Personal Data Protection and ensuring digital rights (LOPD-GDD).

2. For what purposes do we process your personal data?

3. What is the legal basis that allows the processing of your personal data? I.e., what entitles us to process your personal data?

The legal basis that allows us to process your personal data is as follows; (I) your consent granted by means of your signature or acceptance of the relevant forms, for one or several specific purposes, and (II) as the case may be, the execution of a contract of which you are a party, whether as contractor or as successful bidder.

4. For how long do we keep your personal data?

We will keep your personal data during the period necessary to keep a customer record and to manage our services efficiently, provided that the data subject does not request their erasure. Even after an erasure request, they will be blocked during the necessary period, and processing thereof shall be limited to the following cases: to meet legal/contractual obligations of any kind to which we may be subject and/or during the legal statute-barring period for any liability to which we may be subject and/or for the exercise of the defence of any claims resulting from our relationship with the data subject.

5. Who must update the personal data?

We will endeavour to keep the data included in our computer and/or hard copy files updated to ensure that they are always accurate. 6. Who may be assignees or recipients of your personal data?

II- GENERAL INFORMATION

8.a) What are my rights?

Data protection regulations allow you to exercise rights of access, rectification, opposition, portability, erasure (“right to be forgotten”), limitation of processing and the right not to be subject to individualised decisions, TELEFÓNICA FACTORING ESPAÑA,S.A., in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter “GDPR”) and Organic Act 3/2018, of December 5, on Personal Data Protection and ensuring digital rights (LOPD-GDD):

8.a.1 RIGHT OF ACCESS

You have the right to be aware of the following:

- Whether or not we are processing personal data concerning you.
- The origin of your data, if you didn't provide them.
- The purposes for which your data are processed.
- The data categories in question.
- The recipients or recipient categories to which your personal data were or will be communicated.
- If possible, the period during which your personal data will be kept (or, if not possible, the criteria used to determine this period).
- The right to lodge a claim before a supervisory authority.
- Whether or not we make automated decisions -including profiling- using your personal data.

8.a.2 RIGHT OF RECTIFICATION

You have the right to demand that your personal data be rectified:

- By completing them, if they should be incomplete.
- By updating or rectifying them, if for any reason they should no longer correspond to the current situation or if they should be inaccurate.
- Upon exercise of your right of rectification, we will ensure that all your personal data are accurate and complete.

8.a.3 RIGHT OF ERASURE

You have the right to demand the erasure of your personal data in any of the following cases:

- The data are no longer necessary for the purposes for which they were collected or processed.
- You withdraw your consent which is the basis for the processing of your data and such processing cannot be performed on any other basis.
- You have successfully exercised your right of opposition to the processing of your data.
- Your personal data have been processed unlawfully.

8.a.4 RIGHT OF LIMITATION OF THE PROCESSING

You will be entitled to demand limitation of the processing of your personal data (i.e., for us to keep them without using them for the expected purposes).

8.a.5 RIGHT OF OPPOSITION

You will be entitled to demand that we cease to use your personal data, for example, where you believe that the personal data we have about you may be inaccurate, or if you should believe that we no longer need to use them.

8.a.6 RIGHT OF PORTABILITY

Where the processing of your data is based on your consent, or where it should be necessary for the performance of a contract or preliminary contract, and such processing should be performed by automated means, you will be entitled to the portability of your data, i.e., for them to be delivered to you in a structured, commonly used and mechanically readable format, even to forward them to a new data controller. For these purposes, the entity shall facilitate the portability of your data to the new data controller.

8.b) Who may exercise these rights against TELEFÓNICA FACTORING ESPAÑA,S.A.?

You, as data subject or as titleholder of the personal data, acting in your own name and behalf.

By means of another person acting as your legal representative, duly evidencing his/her representation (e.g., where the holders of parental authority or guardians act in the name of a person under 14 years of age, or when acting as legal representative of a functionally diverse person) or as voluntary representative (a person to whom you have freely and voluntarily granted a power of attorney for these purposes).

8.c) How and where can I exercise these rights?

In both cases, you must:

- Provide sufficient data and information to respond to the request. For these purposes, you may use the forms made available by the Spanish Data Protection Agency <https://www.aepd.es/es/derechos-y-deberes/conoce-tus-derechos>
- Sign the form by hand or, as the case may be, if you should have an officially recognised digital certificate, by electronic signature.
- Enclose or attach a photocopy of your National Identification Document (DNI), Passport, Foreigner Identification Number (NIE) or other equivalent identifying document. If you are acting on behalf of the third party, you must also include a copy of your DNI or equivalent identification document, and the document evidencing your representation of the data subject.
- Send the form and evidence of your identity to Telefónica Factoring España, S.A. by any of the aforementioned means.

8.d) Additional information

TELEFÓNICA FACTORING ESPAÑA,S.A. shall analyse whether or not the request is in accordance with the law. It will communicate its decision to the petitioner, proceeding in consequence: If it should find in favour of the request, it will adopt the requisite measures depending on the right that was exercised; if it should find against the petitioner, it will indicate any appeals the petitioner is entitled to bring legally. If the requests should be manifestly unfounded or excessive (e.g., repetitive), TELEFÓNICA FACTORING ESPAÑA, S.A. may: (i) charge a fee proportional to any administrative costs it has borne (ii) refuse to act.
