#### 1. Introduction

TELEFÓNICA FACTORING is registered with the Madrid Commercial Register, Volume 649, General 234 of Section 3 of the Companies' Book, Sheet 136, Page 1870 Tax Identification Number (CIF) A-28016798

TELEFÓNICA FACTORING informs of the General Terms and Conditions regulating access to, browsing and use of the Web Portal.

TELEFÓNICA FACTORING may, at any time and without prior notice, amend the General Terms and Conditions of Use and, as the case may be, any Specific Terms and Conditions that may be established. Before browsing the Website, a careful reading of the present "Legal Notice" is recommended.
